- Help Out Your Neighbors –Maybe there is an older couple in your neighborhood. Help as a family with some yard work or take them a nice meal. If you have a family who has a family member at war, show kindness by taking some cookies or some other treat to the family.
- Deliver Food Items Have your children help you buy and save up food items. Drop them off at local food banks. Another idea is to build up a food basket full of food items and take it to a family in need. Let kids help pick out foods and allow them to decorate the basket or package to give to someone who needs it.
- Volunteer at a soup kitchen.
- Pack lunches and deliver them to the homeless. Have the kids design a menu that is a balanced meal and will fit in a bag.
- Visit people that are unable to leave their homes.
- Pick-up Trash- Find a place that is in need of being cleaned up, and pick-up trash as a family. Set a goal to fill a trash bag for each person.
